A. MODE OF MEETING

The AGM will be conducted entirely through live streaming using remote participation and voting ("**RPV**") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via TIIH Online website at <u>https://tiih.online</u>. Shareholders are to participate, speak (via real time submission of typed texts only) and vote remotely using the RPV facilities.

Pursuant to Section 327(2) of the Companies Act 2016, the Chairman shall be present at the Broadcast Venue being the main venue of the AGM. Shareholders will not be allowed to attend the AGM in person at the Broadcast Venue on the day of the Meeting.

B. APPOINTMENT OF PROXY/AUTHORISED REPRESENTATIVE/ ATTORNEY

If you wish to appoint proxy to participate and vote at the AGM on your behalf, you must ensure that the duly executed Proxy Form is deposited either in a hard copy form at Tricor's office or by electronic means via TIIH Online website at <u>https://tiih.online</u> no later than **Sunday, 24 October 2021 at 2.30 p.m.** (Please refer to the Procedures in Section D below).

Authorised representative of corporate member or attorney must deposit their original Certificate of Appointment of Authorised Representative or the Power of Attorney at Tricor's office before the time appointed for holding the AGM for the appointment to be valid for the purposes of attending the AGM.

C. PROCEDURES FOR USING THE RPV FACILITIES

Only shareholders whose name appears in the Record of Depositors as at **18 October 2021** shall be entitled to participate, speak and vote at the AGM or to appoint proxy, authorised representative or attorney, as the case maybe, to participate, speak and vote on their behalf at the AGM.

For shareholder/proxy/authorised representative/attorney who wish to participate in the AGM, please refer to the following procedures for using the RPV facilities:

1.	Register as a user with TIIH Online	 Using your computer or smartphone, access the website at <u>https://tiih.online</u>. 		 Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your vote for the resolutions tabled for voting. Confirm and submit your vote.
6.	End of remote participation and voting	Upon the announcement to be made by the Chairman on the closure of the AGM, the live streaming will end.

Notes to the RPV facilities users:

- (i) Should your application to join the AGM be approved, the system will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the AGM will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the Internet connection at your location and the device you use.

D. APPOINTMENT OF PROXY(IES)

The AGM will be conducted fully virtual. If you are unable to participate, speak and vote at the AGM via RPV facilities on 26 October 2021, you may appoint a proxy or not more than two (2) proxies or the Chairman of the Meeting as Proxy to attend the AGM on your behalf.

You may submit your Proxy Form to Tricor's office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or at its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, not less than forty-eight (48) hours before the time appointed for holding the AGM, otherwise the Proxy Form shall not be treated as valid.

You may also submit the Proxy Form by electronic means via TIIH Online website at <u>https://tiih.online</u> no later than **Sunday, 24 October 2021 at 2.30 p.m**.. Please do read and follow the procedures below to submit the Proxy Form by electronic means.

1.	Register as a user with TIIH Online	 Using your computer or smartphone, access the website at <u>https://tiih.online</u>. Register as a user under the "e-Services", select the "Sign Up" button and followed by "Create Account by Representative of Corporate Holder". Please refer to the tutorial guide posted on the homepage for assistance. Complete the registration form and upload the required documents. Registration will be verified, and you will be notified by email within one (1) to two (2) working days. Proceed to activate your account with the temporary password given in the email and re-set your own password. Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can proceed with submission of Proxy Form mentioned in 2 below. 2.	Proceed with submission of Proxy Form	 After the release of the Notice of AGM by the Company, login to TIIH Online at <u>https://tiih.online</u> with your user ID and password. Select the corporate event: "ANCOM 52nd AGM – SUBMISSION OF PROXY FORM". Read and agree to the Terms & Conditions and Declaration. Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein. Prepare the file for the appointment of proxy by inserting the required data. Log in again to TIIH Online at <u>https://tiih.online</u>, select the corporate event: "ANCOM 52nd AGM – SUBMISSION OF PROXY FORM" Proceed to upload the duly completed proxy appointment file. Select "Submit" to complete your submission. Print the confirmation report of your submission for your record. 				

Proxy/authorised representative/attorney who wishes to participate, speak and vote in the AGM via the RPV facilities must first register himself/herself for the RPV facilities at TIIH Online website at <u>https://tiih.online.</u> Please refer to the procedures for using the RPV facilities stated in Section C above.

E. POLL VOTING

Pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, all the resolutions set out in the Notice of AGM will be put to vote by poll.

Shareholders can proceed to vote on the resolutions at any time from the commencement of the AGM until the end of the voting session which will be announced by the Chairman of the Meeting.

Upon completion of the voting session for the AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

F. NO RECORDING/PHOTOGRAPHY

Unauthorised recording and taking photographs of the proceedings at the AGM is strictly prohibited.
