A. MODE OF MEETING

The EGM will be conducted entirely through live streaming using the remote participation and voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via TIIH Online website at https://tiih.online. Shareholders are to participate, speak (via real time submission of typed texts only) and vote remotely using the RPV facilities.

Pursuant to Section 327(2) of the Companies Act 2016, the Chairman shall be present at the Broadcast Venue being the main venue of the EGM. Shareholders will **NOT** be allowed to attend the EGM in person at the Broadcast Venue on the day of the Meeting.

B. APPOINTMENT OF PROXY/AUTHORISED REPRESENTATIVE/ATTORNEY

If you wish to appoint proxy to participate and vote at the EGM on your behalf, you must ensure that the duly executed Proxy Form is deposited either in a hard copy form at Tricor's office or by electronic means via TIIH Online website at https://tiih.online no later than Wednesday, 18 May 2022 at 10.00 a.m. (Please refer to the Procedures in Section D below).

Authorised representative of corporate member must deposit the ORIGINAL Certificate of Appointment of Authorised Representative at Tricor's office before the time appointed for holding the EGM for the appointment to be valid for the purposes of attending the EGM.

For an attorney appointed via a Power of Attorney, the Power of Attorney or a notarially certified copy of such Power of Attorney must be deposited at Tricor's office not later than **Wednesday**, **18 May 2022 at 10.00 a.m.** for the appointment to be valid for the purposes of attending the EGM.

C. PROCEDURES FOR USING THE RPV FACILITIES

Only shareholders whose name appears in the Record of Depositors as at 12 May 2022 shall be entitled to participate, speak and vote at the EGM or to appoint proxy, authorised representative or attorney, as the case maybe, to participate, speak and vote on their behalf at the EGM.

For shareholder/proxy/authorised representative/attorney who wish to participate in the EGM, please refer to the following procedures for using the RPV facilities:

		 Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your vote for the resolutions tabled for voting. Confirm and submit your vote. 			
6.	End of remote participation and voting	Upon the announcement to be made by the Chairman on the closure of the EGM, the live streaming will end.			

Notes to the RPV facilities users:

- (i) Should your application to join the EGM be approved, the system will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of the EGM will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the Internet connection at your location and the device you use.

D. APPOINTMENT OF PROXY(IES)

The EGM will be conducted fully virtual. If you are unable to participate, speak and vote at the EGM via the RPV facilities on Friday, 20 May 2022, you may appoint a proxy or not more than two (2) proxies or the Chairman of the Meeting as Proxy to attend the EGM on your behalf.

You may submit your Proxy Form to Tricor's office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia, or at its Customer Service Counter at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia, not less than forty-eight (48) hours before the time appointed for holding the EGM, otherwise the Proxy Form shall not be treated as valid.

- · Proceed to upload the duly completed proxy appointment file.
- Select "Submit" to complete your submission.
- Print the confirmation report of your submission for your record.

Proxy/authorised representative/attorney who wishes to participate, speak and vote in the EGM via the RPV facilities must first register himself/herself for the RPV facilities at TIIH Online website at https://tiih.online. Please refer to the procedures for using the RPV facilities stated in Section C above.

E. POLL VOTING

Pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, all the resolutions set out in the Notice of EGM will be put to vote by poll.

Shareholders can proceed to vote on the resolutions at any time from the commencement of the EGM until the end of the voting session which will be announced by the Chairman of the Meeting.

Upon completion of the voting session for the EGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

F. NO RECORDING/PHOTOGRAPHY

Unauthorised recording and taking photographs of the proceedings at the EGM is strictly prohibited.
